FIRST AMENDMENT TO THE SECOND AMENDED AND RESTATED COVENANTS, CONDITIONS, AND RESTRICTIONS ("CC&RS") FOR

OAK RIDGE ESTATES AT 3F MEADOWS

THIS FIRST AMENDMENT TO THE SECOND AMENDED AND RESTATED COVENANTS, CONDITIONS, AND
RESTRICTIONS ("CC&RS") FOR OAK RIDGE ESTATES AT 3F MEADOWS ATASCADERO, CA (ATAL 00-192)
made this 21 day of Warch, 2013 by K&M Holding Corporation, a California
Corporation, and Castlerock Development, a California Corporation (hereinafter collectively referred to
as "Declarant") is made with regard to the following facts:

RECITALS

1) Whereas, that certain <u>Covenants</u>, <u>Conditions</u>, <u>And Restrictions</u> ("CC&Rs") For Oak Ridge Estates At 3F <u>Meadows Atascadero</u>, <u>CA (ATAL 00-192)</u> as recorded in official records of San Luis Obispo County on February 27, 2003 as Document No. 2003019455 was subsequently amended and restated by that certain <u>Second Amended And Restated Declaration Of Covenants Conditions</u>, <u>And Restrictions</u> ("CC&RS") For Oak <u>Ridge Estates At 3F Meadows</u>, <u>Atascadero</u>, <u>CA (ATAL 00-192)</u>, as recorded in official records of San Luis Obispo County on September 3, 2004 as Document No. 2004078839 (hereinafter referred to as the "CC&Rs"); and

- 2) Whereas, that certain <u>Declaration Of Covenants Establishing Maintenance</u>, Repair And Improvement <u>Obligations For Oak Ridge Estates At 3F Meadows Atascadero</u>, <u>CA (ATAL 00-192)</u> as recorded in official records of San Luis Obispo County on February 27, 2003 as Document No. 2003019456 was subsequently amended and restated by that certain <u>First Amended and Restated Declaration Of Covenants Establishing Maintenance</u>, Repair And Improvement Obligations For Oak Ridge Estates At 3F Meadows, Atascadero, CA (ATAL 00-192), as recorded in official records of San Luis Obispo County on July 31, 2003 as Document No. 2003084986; and
- 3) Whereas, CC&Rs Section 1 of Article VII- Owners' Consent to Amendment/Revocation allows for amendments to the CC&Rs after the first conveyance of a Parcel upon the written approval of the then record Owners of at least fifty-one percent (51%) of the Parcels; and
- 4) Whereas, Declarant currently owns more than fifty one percent (51%) of those certain properties that are part of Oak Ridge Estates at 3F Meadows, Atascadero, CA (ATAL 00-192) as shown on the map thereof recorded February 27, 2003 in Book 58, Page 1-22 of Parcel Maps in the Office of the County Recorder of San Luis Obispo County (hereinafter "Properties" collectively, or "Property" individually); and
- 5) Whereas, Declarant now wishes to amend the CC&Rs as provided hereinafter in conjunction with the Second Amended And Restated Declaration Of Covenants Establishing Maintenance, Repair And Improvement Obligations For Oak Ridge Estates At 3F Meadows, Atascadero, CA (ATAL 00-192) recorded concurrently herewith, in the office of the County recorder of San Luis Obispo County, CA.

NOW, THEREFORE, Article IX- Miscellaneous Provisions, Section 16- <u>Public Road Maintenance</u> <u>Responsibility</u> is amended to read as follows:

SECTION 16 Public Road Maintenance Responsibility

Certain residential Lot Owners shall have a prorated share of the financial responsibility for the continued maintenance of the following roads and ancillary drainage structures within the project boundaries of Oak Ridge Estates, as delineated on sheets 9 through 22, inclusive, of Parcel Map ATAL 00-192: San Marcos Road, Cenegal Road, Cabazon Road, Puente Road, Madrone Road, San Cayetano Road, San Marcos Court, San Felipe Court, Escabroso Court, Pecos Court, Rojo Court, and Paso Verde Court.

This financial responsibility shall be allocated and implemented as described in the Second Amended and Restated Declaration Of Covenants Establishing Maintenance, Repair And Improvement Obligations For Oak Ridge Estates At 3F Meadows, Atascadero, CA (ATAL 00-192), as recorded in official records of San Luis Obispo County on 304 2013 as Document No. 2013 038661

The requirements of this Section 16 shall remain in effect until such time as one of the following occurs, and whichever of these occurs first shall result in the termination of this Section 16:

- 1. The Atascadero City Council accepts the dedications and maintenance of the above identified roads; or
- 2. A Maintenance Assessment District for the above identified roads is established and subsequently approved by the Atascadero City Council; or
- 3. Another comparable Declarant and/or Lot Owner plan or method to address continued maintenance for the Public Roads within Oak Ridge Estates is approved by the City Engineer and Community Development Director.

In the event of the violation of any of the above covenants of this Section 16 or attempt to violate any of the above covenants of this Section 16 prior to their termination as herein above set forth, it shall be lawful for the Declarant, and/or the Lot Owner (or Lot Owners) of any other parcel to prosecute any proceedings at law or in equity against the person or persons violating or attempting to violate any of the above said conditions, and either to prevent him/her/them from doing so or to recover damages for such violation.


